

NOMINATION for SERVICE TO VOLUNTEERS AWARD



Description: Recognizes the outstanding service of a GSVSC employee that benefits two or more service units.

Criteria:

1. Must be an active member of GSVSC staff for a minimum of two years at the time of the nomination.
2. Service is consistently outstanding and beyond the expectations of the position(s) held.
3. The service described should reflect a commitment to the Girl Scout mission and provide documentation of attention to implied or expressed needs of volunteers.
4. Outstanding service to volunteers in any area, including membership, training, program, public relations, business functions, fundraising, and property management, will be considered.
5. Service must be of direct benefit to volunteers in reaching the Girl Scout and GSVSC mission.

Letters of support (Form 4065) are needed from three additional individuals from two or more Service Units.
