



Parent/Guardian Permission & Responsibility Agreement

2024 Fall Product Program: September 30 – November 4, 2024

This agreement must be completed and turned into your troop program manager before any girl materials will be released. Girls without an agreement on file may not participate in the Fall Product Program.

My Girl Scout, _____, a member of Troop # _____, has my permission to participate in the 2024 Fall Product Program (September 30 – November 4, 2024). I will see that she honors all rules and procedures as set by Girl Scouts of Virginia Skyline Council (GSVSC) and that she has adult supervision and guidance.

Please initial the 12 items below indicating your agreement.

1.		My Girl Scout is a registered member of Girl Scouts for the 2024-25 Membership Year.
2.		I accept personal financial responsibility for all products she receives, and monies collected as payment from customers.
3.		I understand that Fall Product Program proceeds are for the troop and GSVSC; and that the funds are for Girl Scout activities and are not to be retained by individuals for personal use.
4.		I agree that all money collected will be given to my Girl Scout's troop by the GSVSC set deadlines and I understand that GSVSC reserves the right to seek the services of a collection agency and/or pursue legal action for delinquent accounts.
5.		I understand that should any outstanding balance be sent to a collections agency I will be held responsible for that amount, in full, as well as all administrative costs incurred by GSVSC during the collections process to the full extent of the laws in the Commonwealth of Virginia.
6.		I agree to attend a training session and not to begin selling Fall Product Program items before the official start date of September 30, 2024, and to follow all other rules set by GSVSC.
7.		Unsold products may not be returned to GSVSC offices, the troop, or the service unit cupboard. Any fall products remaining unsold in my possession after the program will be considered my property, and I accept financial responsibility for it.
8.		Adults serve in a supporting role for girls and should not assume responsibility for sales, but rather focus on the Girl Scout process of Girl Led, Learning by Doing, and Cooperative Learning.
9.		I understand that the troop program manager will give me a signed receipt for all products I receive and all money I turn in, and that it is my responsibility to keep copies for six months.

10.		I understand that it is my responsibility to enter my Girl Scout's orders in M2 Media by October 26, 2024, and/or give a copy of her paper nut & candy order card to my troop program manager before October 26, 2024. Failure to do so may result in product not being ordered for my Girl Scout.
11.		I have received and read the 2024 GSVSC Fall Product Program Family Guide. I agree to be bound by the Girl Scouts of the USA and Girl Scouts of Virginia Skyline Council's product program guidelines and policies.
